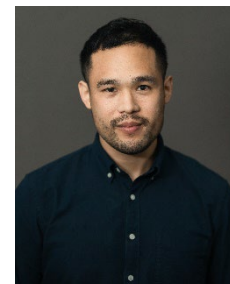

**Transitional Housing Project at Hung Yuen Road, Hung Shui Kiu, Yuen Long, New Territories** – Transitional Housing development consisting of two 4-storey residential blocks with Modular Integrated Construction (MiC) method, providing 404 units on a 5,339 m<sup>2</sup> site located at Hung Yuen Road, Hung Shui Kiu. Full landscape design consultancy service.

**LP6 – Site N of TKOTL70 RP, LOHAS Park Package 6** – High quality 2400 unit residential development located at LOHAS Park Site N for JV MTRC and Nan Fung Developments. Site area is 1.35ha and will accommodate over 2400 apartments in 4 towers. ### **COMMERCIAL DEVELOPMENT**

**Site 3, Inland Lot No. 9088, New Central Harbourfront, Hong Kong** - Executive Landscape Consultancy Services for this iconic 400m-long mixed-use development linking the historic CBD of Central District, Hong Kong with the Victoria Harbour Waterfront. The tender-competition-winning design features public open spaces at multiple levels including the tree-lined Grand Boulevard, the Star Ferry Clock Tower Plaza and al fresco dining at ground level; a large multi-purpose Countdown Plaza and Eco Garden on the first floor with a Harbour Amphitheatre of steps leading down to the waterfront; a shady Chill-Out Space at the second floor and a major 300m-long 'Rolling Forest' roof garden exploiting the spectacular views and providing a biodiverse and biophilic landscape experience for Hong Kong citizens and tourists alike.

**Commercial Development at New Kowloon Inland Lot No. 6556 – Kai Tak Area 1F Site 2, Kowloon** – Executive landscape design services for this prime CDA site in the heart of the new Kai Tak City District next to Kai Tak River and Station Square. Development includes office, retail and hotel components with a low rise structure in the west and a landmark high rise tower in the east. Extensive landscape areas included at streetscape level, on the cascading podium levels and on the landmark tower. The landscape is based on a contemporary Chinese style and makes references to the history of Too Kwa Wan Island.

The study included analysis of case studies from around the world and the incorporation of best practice in modern botanical gardens into the proposed masterplan.
